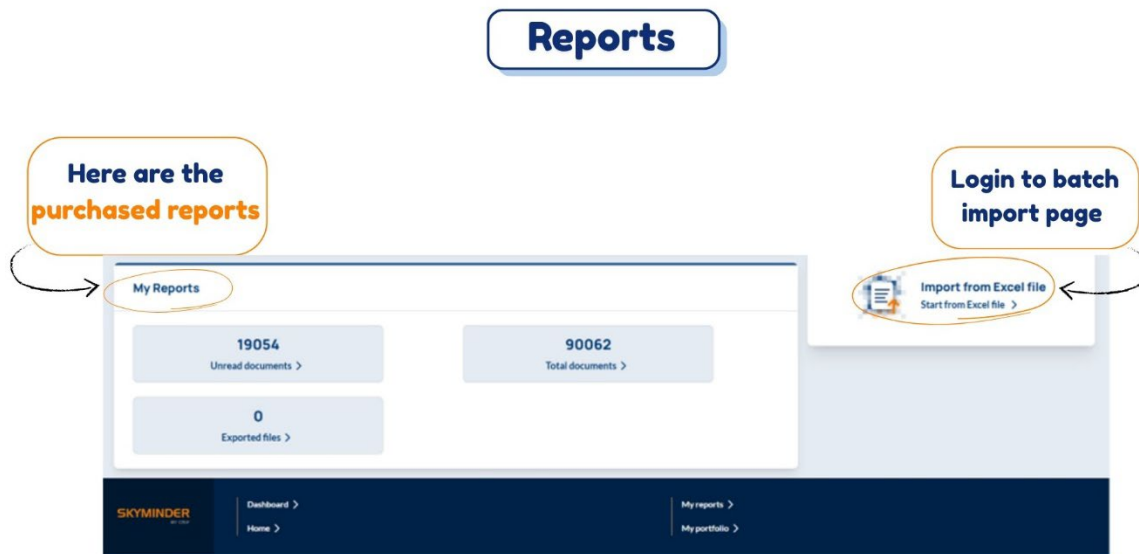

SEARCH AND ORDER A REPORT

Quick search bar

In order to search for a company, click on the search bar and start the search, choosing from the dropdown menu the appropriate country and the country name. Moreover, if available, you can also search by Local Business ID.



How to

1. From the dropdown menu, choose the appropriate **country**

2. Type the **company name** in the designated field

3. Press the **Search** button to display results



How to



1. Select Search Type (company, person, official registries, LEI)

3. Search by company name or local business ID

4. Insert company name (or local business ID) and city (optional), then click on Search



After the search, results are displayed. You can select the company from the list. If the entity you're looking for is missing, you can edit the search criteria on the left and search again, or click "Can't find what you're looking for?" to request the entity even if it's not listed.





VIEW REPORT

Tabs for the different sections are now displayed vertically on the left side of the screen. To move between sections, click on the corresponding tab.






